

Position: Warehouse Operator – Class 1

Reports to: Warehouse Foreman or Supervisor

Minimum Qualifications (preferred): High school diploma, or equivalent, or 5-7 years warehouse experience.

Key Responsibilities: This position requires intimate knowledge of warehouse practices, surroundings, and raw materials stocked in the warehouse. These materials include structural, tubing, pipe, and bar stock items such as: channels, beams, angles, flats, rounds, pipe and tubing products. Also required is the ability to determine the grade of material (alloy, carbon, stainless, aluminum, brass, bronze, plastic, etc.) based on manufacturer or LMF tags/markings. This position must be able to read and write the English language. Also must be able to read and comprehend measuring devices. This position also requires abilities to work with varied dimensions and measures. This position requires a working knowledge of the AS400 computer system and must be able to use and operate the Warehouse PC and software. This position works closely with all departments of LMF and external customers. Must be able to load customer vehicles and unload LMF and vendor trucks.

Job Responsibilities and duties for this position:

- Adheres to all plant safety rules and procedures.
- Able to identify all material grades and classifications.
- Complete knowledge of racking system.
- Set-up and operate production equipment, as required.
- Operates production equipment while under the supervision of the Warehouse Supervisor.
- Identifies and segregates suspect parts with quality issues.
- Records production and operational information, as required.
- Demonstrate the ability to complete all necessary AS400 data entry.
- Processes all documentation per written or verbal instructions.
- Reads blueprints, drawings, or written specifications to determine the appropriate process and equipment.
- Keeps work area neat and clean.
- Performs preventative maintenance on production equipment, as required.
- Perform miscellaneous duties as required by the position or Warehouse Supervisor.
- Inspect parts and materials from receiving through finished product, as appropriate.
- Appropriately identify and package parts for next operation or customer.
- Loads customer vehicle.
- Unloads LMF and vendor trucks.
- Run fork truck, stacker crane, overhead crane, etc.
- Demonstrate a complete working knowledge of all measuring devices.

- o If a document that you are using needs revision, make the department management or the Quality Assurance office aware so the appropriate changes can be made. If it isn’t right, let someone know. You are the most accurate input for changing documents.
